Established in 1939 and chartered in 1949, Legal Aid has 23 staff attorneys who handle a variety of matters for indigent individuals, children and families in the following areas: family, domestic violence, guardian ad litem, guardianship, housing, benefits, teen advocacy and bankruptcy.
